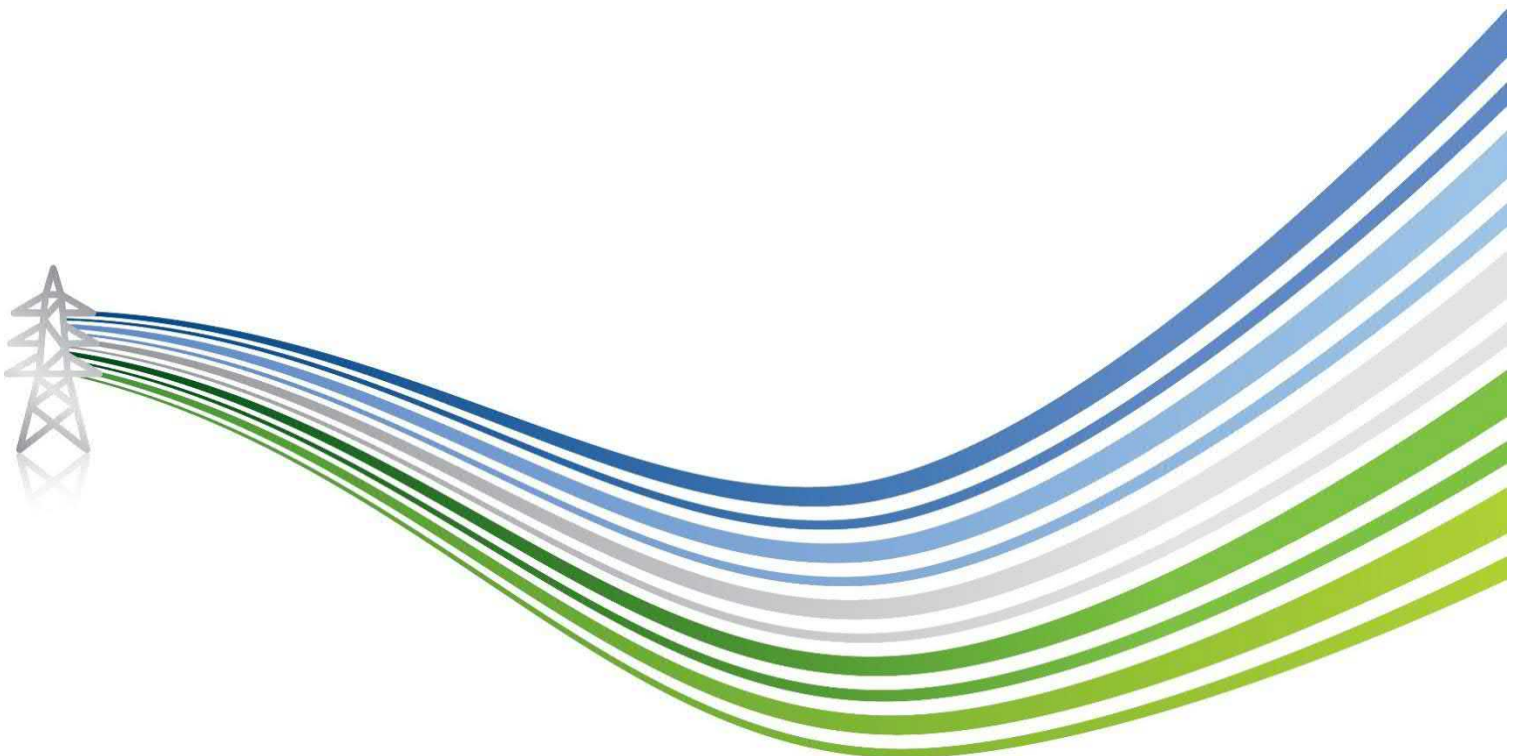

1 INTRODUCTION

1.1 Purpose of Document

- 1.1.1 This Pre-Application Consultation (PAC) Report is submitted by Scottish Hydro Electric Transmission plc, operating and known as Scottish and Southern Electricity Networks Transmission (SSEN Transmission), as part of an application for full planning permission under the Town and Country Planning (Scotland) Act 1997 (as amended) ('TCPA 1997') to construct and operate a new substation and associated infrastructure (the 'Proposed Development') close to the existing Deanie substation. The Proposed Development is in Glen Strathfarrar, Highland. Therefore, there is a statutory requirement to undertake public consultation in accordance with the Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013 (SSI 2013/155).
- 1.1.2 The Proposed Development falls within the category of 'National Development' under the Town and Country Planning (Hierarchy of Development) (Scotland) Regulations 2009 (the Hierarchy Regulations). Therefore, there is a statutory requirement to undertake public consultation in accordance with the Town and Country Planning (Development Management Procedure) (Scotland) Regulations (DMRs) 2013 (SSI 2013/15).
- 1.1.3 The PAC Report documents the pre-application consultation process for the project which has been undertaken prior to submission of the application. The programme of consultation was designed to engage with The Highland Council, statutory and non-statutory consultees, the local community, landowners, and individual residents to both Inform and invite feedback on the proposals and provide a follow up opportunity to present responses to feedback provided.
- 1.1.4 The PAC report describes the key responses and details the actions taken in response to any issues raised.

1.2 Document Structure

- 1.2.1 This PAC Report is comprised of five parts as follows :
- 1: Introduction – sets out the purpose of the Pre-Application Consultation Report;
 - 2: Proposed Development – outlines the background to the project and provides a description of the key elements;
 - 3: The Consultation Process – describes the framework for consultation and methods which have been employed, including advertisements;
 - 4: Public Responses and Key Issues – summarises the range of responses and key comments and issues arising through the public consultation events and also summarises project responses to consultations – describes how the comments and issues raised during consultation have and will be addressed; and
 - 5: Conclusions and Next Steps – provides a summary of the conclusions reached and actions going forward.
- 1.2.2 The PAC Report is supported by a series of appendices.

2. PROPOSED DEVELOPMENT

2.1 Project Background, the Proposed Development Need

- 2.1.1 There is a requirement for SSEN Transmission to replace the existing Deanie substation which converts the 11kV output to 132kV, for export to the Transmission network. This is driven by operational requirements and asset condition assessments of the existing substation serving the hydroelectric power station at this location. The existing substation was built in the 1960s, solely to connecting the hydroelectric generation assets to our transmission network, which is coming to the end of its operational life. The deterioration in current asset condition poses a risk of failure, resulting in the hydroelectric power station unable to distribute renewable power and risking network reliability of electricity supply to customers. SSEN Transmission owns and maintains the electricity transmission network across the north of Scotland and holds a license under the Electricity Act 1989 to develop and maintain an efficient, co-ordinated and economical system of electricity transmission.
- 2.1.2 The Proposed Development seeks to replace the existing substation and ensure ongoing reliability of supply. The replacement substation will comprise defined platform area, erection of control building, associated plant and infrastructure, alongside ancillary development including drainage infrastructure, temporary construction compound and laydown area(s) as required, new permanent access and landscaping requirements (triggering a National Development). Beyond this, any redundant SSEN Transmission infrastructure within the existing substation platform will be decommissioned and removed (as applicable), with new switchgear installed to control the supply between the existing hydro power station and the new replacement substation.
- 2.1.3 A formal request for an Environmental Impact Assessment (EIA) Screening Opinion under the Town and Country Planning (Environmental Impact Assessment) (Scotland) Regulations (2017) was undertaken, determining that the proposals would fall under EIA development.

2.2 Requirement for Pre-application Consultation

- 2.2.1 Regulation 4 of the DMRs requires that pre-application consultation is carried out for all major and national developments. Major and national development types are defined by the Town and Country Planning (Hierarchy of Development) (Scotland) Regulations 2009 ('the Hierarchy Regulations').
- 2.2.2 National developments are developments or classes described as such in National Planning Framework 4 (NPF4).

3. THE CONSULTATION PROCESS

3.1 Overview

- 3.1.1 This section describes the methods and background throughout the consultation process and provides information on meetings and consultations held with stakeholders to obtain feedback on the application prior to submission; in accordance with Section 35B of the Town and Country Planning Act (1997) and Regulation 7 of the Development Management Regulations (2013).

3.2 Early Non-Statutory Consultation

- 3.2.1 A Community Liaison Group (CLG) was set up In Beauly as part of previous developments in the area to provide a forum for discussion of development plans for SSEN Transmission infrastructure in the area, including this Proposed Development. The CLG contains members of the local community, nearby residents and representatives from The Highland Council. A site selection exercise was undertaken, and the options first consulted on in June 2022. This Included the CLG, Site Selection Report to Statutory Consultees and public consultation at Cannich and Kilmorack halls.

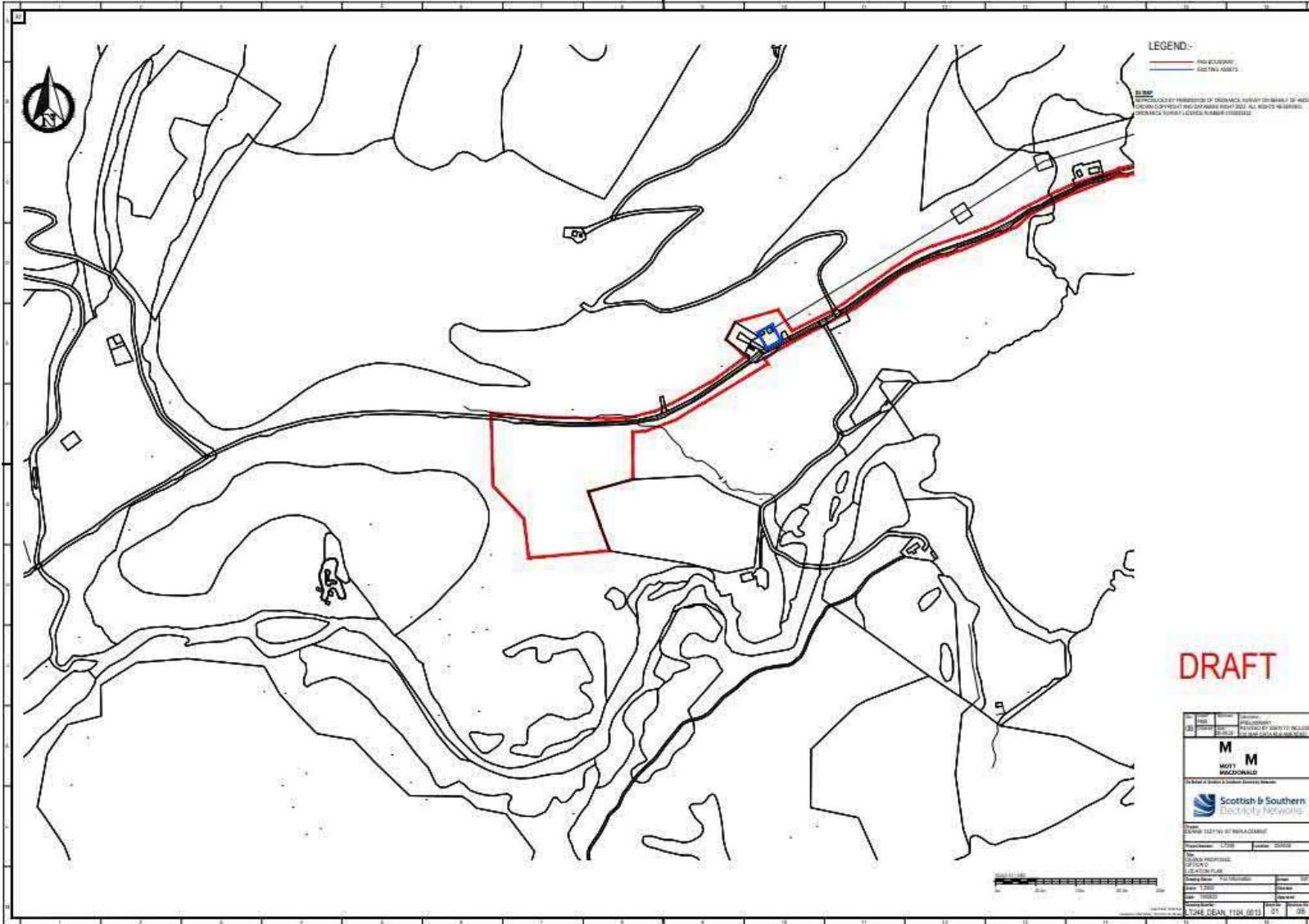
3.3 Pre-application Request with Local Planning Authority

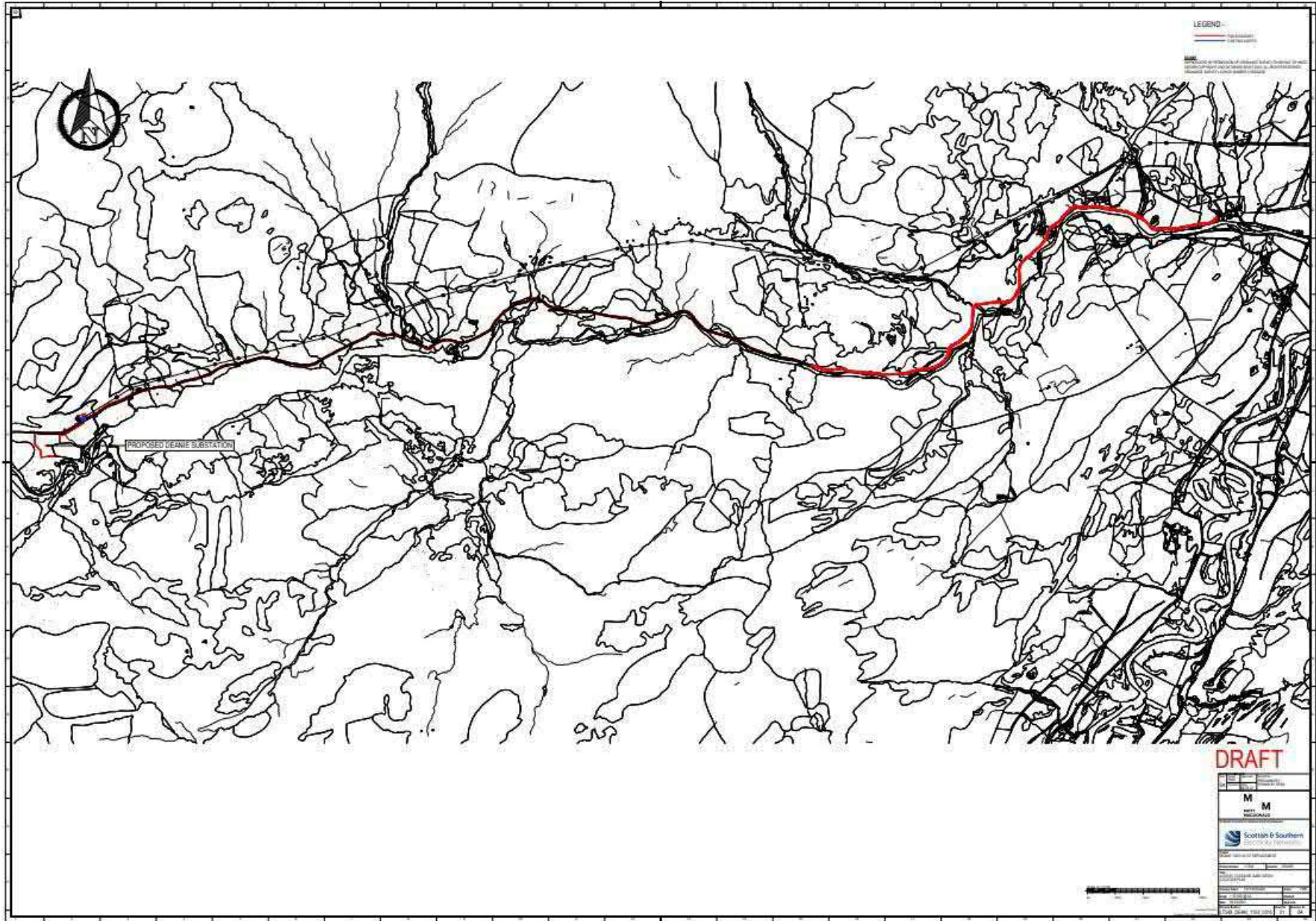
- 3.3.1 A meeting following a formal request for Pre-Application Advice was conducted with The Highland Council (THC) on the 14th of September 2022 (Reference 22/03238/PREMAJ). Written feedback from this pre-application request provided from THC and statutory consultees was then taken forward into the detailed site selection process.
- 3.3.2 Site Options A, B, and D were taken forward to Detailed site selection. Site Option D was ultimately selected as the preferred site, based on least potential for environmental and technical constraints. The Site Options are outlined on Plate 1 below.
- 3.3.3 The Proposal of Application Notice (PAN) Red Line Boundary, which was consulted on is shown on Plate 2. This shows the location and the maximum extent of the proposed development. The final design falls within the PAN Red Line Boundary and details of the design submitted can be found in the Planning Application and supporting documentation.

3.4 Proposal of Application Notice

- 3.4.1 A PAN must be submitted to the Local Planning Authority (LPA), containing the information prescribed in 35B(4) of the TCPA 1997 and Regulation 6 of the DMRs, including an account of what consultation the applicant intends to undertake and information as to when such consultation is to take place, with whom and what form it will take.
- 3.4.2 A Proposal of Application Notice (PAN) was submitted to The Highland Council on 13 October 2022, triggering the consultation period. The PAN provided THC with an outline of the application details, and confirmation of the site location and application boundary. A copy of the PAN is provided in Appendix A.
- 3.4.3 In addition to the PAN and attachments being sent out to THC, below is a list of other parties notified via e-mail on 13 October 2022:

3.5 Discussion with Statutory Consultees

- 3.5.1 SSEN Transmission has been proactive in discussions with prior to, and during the PAN notice period. This has involved telephone and email communication to discuss the proposals and provide updates about submission timescales. Regular updates have been provided to aforementioned Ward 12 Councillors and the Beauly CLG (Beauly CC, Kilmorack CC, Kiltarlity CC, Strathglass CC, Kirkhill & Bunchrew CC) in the form of face-to-face meetings, presentations and emails.

3.6 History of Public Consultation Events

- 3.6.1 In June 2022, local community members and statutory consultees were invited to comment on the proposals for the location of the new Deanie substation. Six options were presented and the SSEN preferred options identified. Further face to face consultation events in the form of two formal Proposal of Application events were held in October/November 2022 and followed up October 2023 with the concluding public feedback event.
- 3.6.2 Due to restrictions in place around social gatherings because of Covid-19 pandemic, the first of three public consultations in June 2022 included a virtual event alongside two face-to face events held at Cannich Hall and Kilmorack Hall. A bespoke online consultation platform was developed for the virtual event which allowed stakeholders to experience the full exhibition from home on a computer, tablet, or mobile device. It was designed to look and feel like a face-to-face consultation in a community hall, with exhibition boards, maps, interactive videos. It provided the opportunity to share views on the proposals. The live-chat function allowed attendees to ask questions and get responses from the project team.
- 3.6.3 Following each of the consultation events, SSEN Transmission issued an update on the project website thanking members of the public for attending and informing them that all material displayed was available for download on the project webpage(West of Beauly - Asset Replacement Projects - SSEN Transmission (ssen-transmission.co.uk) The updates also confirmed a 4 week feedback period and informed the closing date for feedback on the proposals

3.7 Public Consultation Event 1

- 3.7.1 The first of the two PAN consultation events commenced on 31 October 2022 and the consultation period and closing date for submitting feedback was 29 November 2022. Events took place at Kilmorack Hall and Cannich Hall with the project team in attendance.

At the first PAN event in October 2022 there was a total of 43 attendees, 35 at Kilmorack Hall and 8 attending at Cannich Hall. The project team attended both PAN events to share and discuss the information and listen to comments and feedback.

3.7.2 The PAC stage 1 consultations were communicated and advertised in the following ways:

- The consultation events were advertised in the Press and Journal (Highland) (Appendix C)
- A maildrop leaflet were sent to 2,123 properties (this was a collective 2km radius of all 4 of the identified proposed substation replacements at Deanie, Culligran, Aigas and Kilmorack), notifying them of the consultation event (Appendix B)
- Consultation booklets were created for these events providing information about the proposed development. Deanie Substation is detailed on pages 12 and 13. The booklets are available here [SSEN ---West of Beaully---consultation--booklet---oct-2022.pdf \(ssen-transmission.co.uk\)](#).

- Advance notifications ahead of each of the consultation events were provided to Local Elected members, Community Councils, and the Beaully Community Liaison Group – the notification included the link to the project website and the project information booklet
- Advance notifications were also sent to stakeholders who had signed up to be informed of project updates
- Copies of the project information booklets and posters were sent out to community councillors to put on their social media platforms. Posters were put in local shops to promote the events.
- Statutory consultees were informed of these PAN events

3.7.3 A 3D model providing visualisations of the indicative Proposed Development were available at the public events which can be viewed at [West of Beaully - Asset Replacement Projects - SSEN Transmission \(ssen-transmission.co.uk\)](#).

3.7.4 Attendees were invited to feedback comments at the events, through the Feedback Forms at the back of the project information booklet, through the project webpage or via email to the Community Liaison Manager. Stakeholders were informed and directed that they also have the right to comment on the final application through The Highland Council planning portal following submission of the application.

3.7.5 The Table below (section 4) summarises the comments received. Feedback can be grouped into the following five themes: visual impact, noise, electric and magnetic fields, construction traffic and other environmental matters.

3.8 Second PAN Consultation Event

3.8.1 The second and final PAN consultation events commenced on 23rd October 2023 and the consultation period and closing date for submitting feedback was 22nd November 2023. These feedback events took place at Cannich Hall and Kilmorack Hall with the project team in attendance.

3.8.2 At this second PAN event, there was a total of 57 attendees: 42 at Kilmorack Hall and 15 attending the event at Cannich Hall.

The second PAN Consultation events were communicated in the following ways:

- Formal notice and adverts in the Press and Journal (Highland) (Appendix G)
- A maildrop leaflet was sent out to 2,123 properties (collective 2km radius of all 4 of the proposed substation replacement projects covering Deanie, Culligran, Aigas and Kilmorack), notifying them of the consultation event (Appendix I)
- Consultation booklets were created for these events, providing information about the proposed development. Deanie Substation is detailed on pages 9 and 10. The booklets are available here: [ssen----west-of-beaully---october-2023-booklet.pdf \(ssen-transmission.co.uk\)](#)

- Advance notifications ahead of each of the consultation events were provided to Local Elected members, Community Councils, and the Beauly CLG – the notification included the link to the project website and the project information booklet;
- Advance notifications were also sent to stakeholders who had signed up to be informed of project updates;
- Copies of the project information booklets and posters were sent out to community councillors to put on their social media platforms. Posters were put in local shops to promote the events;
- Statutory consultees were informed of these PAN events.

3.8.3 Stakeholders were informed that the event did not remove the right to comment on the final application through the planning portal following a formal planning submission, including how we fed back comments to the first event.

3.8.4 A 3D model providing visualisations of the Proposed Development were available at the public events can be viewed at [West of Beauly - Asset Replacement Projects - SSEN Transmission \(ssen-transmission.co.uk\)](https://www.ssen-transmission.co.uk).

3.8.5 Attendees were invited to feedback comments both at the events and through the Feedback Forms captured at the back of the project information booklet, through the project webpage or via email to the Community Liaison Manager. Stakeholders were informed that they also have right to comment on the final application through The Highland Council planning portal after submission of the application.

3.8.6 The Table in Section 4 summarises the comments received. Feedback has been grouped into the following five themes: visual impact, noise, electric and magnetic fields, construction traffic and other environmental matters.

4. PUBLIC RESPONSES AND KEY ISSUES

4.1 Public Consultation Event

4.1.1 Section 3.7.2 and 3.8.2 provides a summary of how the event was advertised to ensure Stakeholders were aware it was taking place and their feedback was welcomed and encouraged.

4.1.2 SSEN Transmission asked Stakeholders to respond to the following questions:

- Has the requirement for the Asset Replacement projects been clearly explained?
- Based on the information provided do you agree with the preferred site for Deanie Substation?
- Do you have a preference as to whether the equipment is to be indoor or outdoor?
- If your preference is for the equipment to be indoor, what is your preferred colour for the building?
- Are there any additional factors or concerns that you consider important and should be brought to the attention of the project team?

4.1.3 At the public consultation events and through the consultation process, verbal feedback was noted and was also encouraged to formally be submitted through the feedback forms. The feedback forms were included in the Information booklet and were also available to be completed digitally and by email through the projects` web page. The feedback period was open for a 4-week period and was directed to the Community Liaison Manager,

4.1.4 SSEN Transmission received three pieces of written feedback following the PAN Event despite specifically about the proposed Deanie Substation despite various efforts to advertise the events widely. 4.1.4 **Table 1** Summarises the feedback received and the response provided. Feedback is grouped into three key themes: Visual Impact and Impact on Tourism/public interest.

5. CONCLUSIONS AND NEXT STEPS

5.1 Conclusions

This PAC Report documents the consultation events which were designed to engage with Stakeholders, primarily the local community, landowners, individual residents to invite feedback on the Proposed Development. The themes from the 2 pieces of feedback were:

- the visual impact of the substation
- construction traffic impact on tourism and local people

5.1.1 The approach to public consultation has ensured that the local community and `users` of the area have been given the opportunity to comment on the proposals. This has enabled locally important issues and concerns to be identified and subsequently considered in the preparation of the Deanie Asset Replacement consents application.

5.2 Next Steps

5.2.1 SSEN Transmission will continue to engage with Stakeholders and the local community and Beaulieu CLG as the project progresses. Members of the public will also have the opportunity to comment on the Planning application once it has been submitted. Full instructions on how to comment and the timescales for doing so will be advertised in the local press when the application is submitted. Information will be posted on the SSEN Transmission project website and the Beaulieu CLG of which Strathglass Community Council is one of the members will be informed of updates.

TWO men have been jailed after staging a terrifying night-time armed robbery at a house in Aberdeen in which they left their victim bloody and broken after beating him with a metal pole.

Barry Robertson, 52, and Mark Main, 37, also threatened to decapitate the man with ornamental samurai swords as they spent 20 minutes searching his home for items of value.

The men, who each have a history of violence, had been lurking outside their victim's home and were spotted standing on a ladder to peer through a window before bursting inside.

Fiscal depute Ruaridh McAlister

said Main was brandishing a 2ft metal pole with which he struck the man repeatedly, including seven blows to his head, all the while demanding money.

The beating was so severe their victim sustained a broken shoulder and broken finger, together with an array of facial and head wounds.

Alcohol and drugs were said to have played a part in the behaviour of both attackers, but in court Sheriff Graham Buchanan said Robertson was simply such a violent man he "couldn't ever be trusted to reform".

Each man was sentenced to four years in prison, with a further two years of supervision following their release.

Retail chiefs in rates plea

SIMON WARBURTON

Eastgate shopping centre in Inverness is urging Highland Council to use “common sense” in applying any increase in business rates as speculation grows that the tax could increase in line with the spiralling cost of living.

UK inflation is currently running hot at around 10% and the Scottish Retail Consortium (SRC) estimates if business rates rocket at the same pace, it could see retailers slapped with a huge increase in bills of £60 million from next April.

Eastgate centre manager Jackie Cuddy said: “We are aware a revaluation is coming up but we are hoping Highland Council will use common sense in these times of spiralling costs for businesses when making any adjustments.”

The SRC also issued a

plea to the government to give north and north-east companies “breathing space” ahead of any potential rise in business rates in the region.

Meanwhile, business improvement company Inverness Bid also made an impassioned plea for non-domestic rates not to rise as companies face a “perfect storm” of high energy bills, soaring inflation and increasing interest rates.

Inverness Bid director Lorraine Bremner McBride said: “Our city centre businesses, which are at the heart of our community, need support and a period of stability and absolutely not higher non-domestic rates to pay.”

“The message our businesses tell me time and again is rents and rates are too high as it is and in some cases it has already led to doors closing.”

The SRC’s comments come ahead of what it says are “ominous” prospects mooted in the Scottish Spending Review of a further increase in business rates, which are already at a 23-year high.

Describing any inflation-matching hike in business rates as “investment-sapping,” the SRC insisted such a hike would be “gruelling for stores to absorb” and make rejuvenating high streets and retail destinations even harder.

SRC director David Lonsdale said: “It would be putting rocks in the retail industry’s rucksack as it seeks to recover and climb out from some of the worst trading conditions seen in decades.”

The remarks come as latest figures show vacancy rates across Scotland have stalled at 15.7% for the second consecutive quarter.
